David O. Leavitt, Juab County Attorney, State of Utah, accuses the defendant of the following crimes:

COUNT I: CRIMINAL NONSUPPORT, a Third Degree felony, in violation of 76-7-201, Utah Code Annotated, 1953 as amended, in that **THOMAS ARTHUR GREEN**, during the time period of May 1, 1999 through December 31, 1999, in Juab County, Utah, having a spouse, a child, or children under the age of 18 years, he knowingly failed to provide for the support of the spouse, child or children when any one of them, wherein the total arrearage are in excess of \$10,000.00.

ALTERNATIVE "A" AS TO COUNTS II THROUGH V

COUNT II: BIGAMY, a Third Degree felony, in violation of 76-7-101, Utah Code Annotated, 1953 as amended, in that **THOMAS ARTHUR GREEN**, from the fall of 1986 to the present time, (and in Juab County, Utah, since at least early 1996), knowing that he had a wife, cohabited with another person, Linda Kunz Green.

COUNT III: BIGAMY, a Third Degree felony, in violation of 76-7-101, Utah Code Annotated, 1953 as amended, in that **THOMAS ARTHUR GREEN**, from January 1990 to the present time, (and in Juab County, Utah, since at least early 1996), knowing that he had a wife, cohabited with another person, LeeAnn Beagley Green.

COUNT IV: BIGAMY, a Third Degree felony, in violation of 76-7-101, Utah Code Annotated, 1953 as amended, in that **THOMAS ARTHUR GREEN**, from before January 1991 to the present time, (and in Juab County, Utah, since at least early 1996), knowing that he had a wife, cohabited with another person, Cari Bjorkman Green.

COUNT V: BIGAMY, a Third Degree felony, in violation of 76-7-101, Utah Code Annotated, 1953 as amended, in that **THOMAS ARTHUR GREEN**, from January 1991 to the present time, (and in Juab County, Utah, since at least early 1996), knowing that he had a wife, cohabited with another person, Hannah Bjorkman Green.

ALTERNATIVE "B" AS TO COUNTS II THROUGH V

COUNT II: BIGAMY, a Third Degree felony, in violation of 76-7-101, Utah Code Annotated, 1953 as amended, in that **THOMAS ARTHUR GREEN**, from November 1995 to the present time, (and in Juab County, Utah, since at least early 1996), knowing that he had a wife, cohabited with another person, Shirley Beagley Green.

COUNT III: BIGAMY, a Third Degree felony, in violation of 76-7-101, Utah Code Annotated, 1953 as amended, in that **THOMAS ARTHUR GREEN**, from November 1995 to the present time, (and in Juab County, Utah, since at least early 1996), knowing that he had a wife, cohabited with another person, LeeAnn Beagley Green.




